Accessing ShareFile Client account

Why

Your tax documents contain personal information so we want to implement strong cybersecurity measures. The platform ShareFile safeguards your documents and emails by using industry-standard encryption. Encryption protects private information from unauthorized access.

These portals also enable us to share documents with each other in one place, that we can both access later. You'll be able to upload and download documents, including prior year tax returns, using your portal.

- You'll be directed to a ShareFile window where you can create a password that has at least 8 characters in length, 1 upper case letter, 1 lower case letter, 1 number, and 1 special character. Click Save and Sign In.

You'll be directed to a ShareFile window where you can view files that our team has uploaded for you, such as your past year's tax returns, and you can upload your files securely to our team by clicking the lavender (+) button and selecting a file from your device or dragging a file from your device towards the lavender folder icon.
